## MEMBERSHIP MADE EASY

***Using the EFT plan is as easy as 1-2-3 and is the most convenient way to become a continuing member of public radio.***

- 1. Decide how much you want to contribute to St. Louis Public Radio** each month - \$5, \$10, \$25, or whatever amount is right for you.
- 2. Fill out the accompanying authorization form.** The monthly gift you select will be automatically contributed to St. Louis Public Radio through your checking or savings account. Be sure you sign the form after completing it, and send it back with your voided check. Your EFT cannot begin without your authorizing signature.
- 3. Sit back and relax.** Your designated contribution amount will be automatically deducted from your account each month with a record of each deduction appearing on your bank statement. You will also receive an annual comprehensive tax receipt in January of each year. Once you send back the form, you never again have to worry about renewing your membership.

## FREQUENTLY ASKED QUESTIONS

### **What if I wish to increase my monthly EFT contribution?**

*Your written authorization is needed to increase the contribution amount deducted from your account each month. Simply complete the EFT upgrade portion on your Membership Renewal Notice. Be sure to include the amount currently being deducted as well as the increased amount to be deducted and your authorizing signature. Authorization forms are also available through our Membership Office by calling (314) 516-6038.*

### **How do I stop my EFT contributions?**

*When you wish to stop your EFT payments, you do not need to notify your bank - they may charge you unnecessary service fees. St. Louis Public Radio provides this service free of charge. You must provide written notice of termination at least thirty (30) days prior to the effective date of termination. You may also contact us by phone if you prefer.*

### **What if there is a problem with my bank or credit union statement?**

*If you notice any discrepancies on your monthly statement, call us immediately. Our EFT coordinator will personally work with you to correct the problem.*

### **What if I change banks or account numbers?**

*Just mail us a note informing us about the change along with a voided check from your new account. There will possibly be a one-month interruption of your withdrawals in order to make the change. The terms of your previous authorization will remain in effect.*

### **Can I pay through my savings account?**

*Yes, simply send a deposit slip from your savings account instead of a voided check. Please indicate that it is a "savings" account.*

### **How long will it take for EFT draws to begin?**

*It takes approximately one month before your first installment is deducted from your account. We will mail you a verification notice prior to your first draw.*
